### DIRECTIONS FOR USE

#### SPRAY BUFFING DIRECTIONS:

Using either a high speed machine or UHS Burnisher, affix a burnishing pad to the pad driver. Spray POP & SHINE RTU onto a 10' x 10' section of floor (previously coated with floor finish) that you desire to polish. Using the burnishing machine, buff the floor

using straight passes for maximum effectiveness. Buff the floor using a controlled pace for best results; this will work the product into the floor finish film and provide the maximum resulting gloss, durability and performance.

**NOTE:** BE SURE THAT AN ADEQUATE AMOUNT OF FLOOR COATING IS PRESENT ON THE FLOOR.

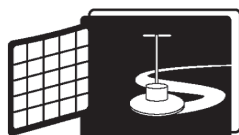
