DIRECTIONS FOR USE

TANNIN OUT™ is a ready to use carpet spot remover for all tannin spots from coffee, tea, rust, blood, oxidized organic residues and severe carpet browning. Utilizes a mild organic acid formulation to work safely and quickly and completely. Contains our exclusive Giane™ fragrance enhancer.

Carpet Spotting

- 1) Pretest carpet for colorfastness in an inconspicuous area.
- 2) Blot up excess liquid with a clean absorbent white cloth.
- 3) Spray TANNIN OUT™ full strength onto spot or stain.

- 4) Allow at least 10 minutes contact time.
- 5) Agitate with a carpet brush or clean cloth.
- 6) Blot with clean absorbent white cloth.
- 7) Repeat as necessary.
- 8) Allow to dry then vacuum.

NOTE: Due to the variety of carpeting materials this product should be tested at recommended use dilution in an inconspicuous area. Use clean cloth or sponge for application and if test area indicates bleeding, color removal, carpet shrinkage or deterioration of adhesive, do not use.
