DIRECTIONS FOR USE

ADDING PRODUCT TO THE DISPENSER

1. Push valve end of bag down onto the pump assembly. (figure 1).
2. Press down on the plastic connector until the bag is fully pressed down and the pump is inserted completely into the pouch (see figure 2).
3. If needed, gently tuck the corners of the bag to ensure complete closure of dispenser cover.
4. Frequent hand washing is one of the simplest and most effective ways to maintain health. Afia™ FOAMING HAIR AND BODY WASH will leave hair and skin clean and fresh.

For Shampooing: Wet hair before applying shampoo. Apply shampoo and work gently into the hair. Rub hair and scalp to create lather. Rinse thoroughly.

For Body Washing: Apply foam to a washcloth or hands. Wash the entire body. Rinse thoroughly.

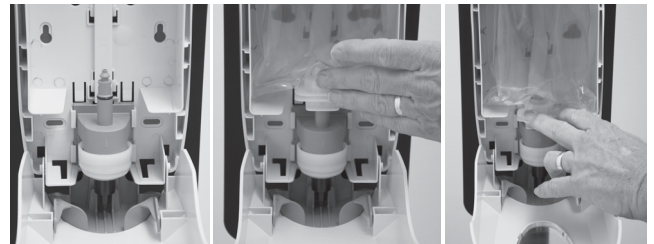
