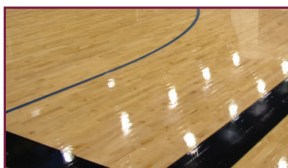
PRODUCT FEATURES / BENEFITS

- Clean and prepare floors for buffing restoration in one step.
- Works with burnisher to enhances gloss and Improve slip resistance
- Extends the useful life of wood floor coating.

DIRECTIONS FOR USE

GLOSS RESTORATION

1. Prepare the floor first by dust mopping or tack cleaning (follow directions on the NCL® Fast Break™ Clean and Tack label) to remove large debris.
2. In an automatic scrubber, mix NCL® GymBuff™ Gloss Restorer at 2 ounces concentrate per gallon of cool water (1:64). Use red or white maintenance pads on the autoscrubber.
3. Autoscrub the floor surface in a single pass. Do not allow cleaning solution to stand on the floor surface. An individual with a pick-up mop or dry towels must follow behind the scrubber to pick up any water that is not picked up by the machine. Pay special attention to corners.
4. Allow floor to dry thoroughly.
5. Burnish floor using a high speed burnisher (1500 RPM or greater) and appropriate high speed burnishing pad.
